

#### PURPOSE

The mission of the 27-4 Long Range Riding Platoon (LRRP) is to foster camaraderie within the chapter through participants attendance at CVMA® events both inside and outside the borders of our home state. Events sanctioned by the NBOD, State and by the 27-4 Chapter Executive Board (CEB). The LRRP is strictly voluntary and is open to all chapter members. An added benefit of the LRRP is that it will be used to maintain a record of a participant's mileage that was devoted to non-profit events. This mileage may be deductible from the participant's income taxes at the end of the calendar year thus providing an added incentive for participants to attend these events. Participation will also foster support to all veterans. This is a program is not designed as a method to segregate members from one another.

### PATCH

The 27-4 LRRP patch is in the shape of a military guidon. The color of the patch shall be black with a gold border. The lettering will be gold for the "CVMA", "27-4" and "LRRP" on the patch. The CVMA skull is centered. The size of the patch will be approximately 4 ¼ wide x 2 ½ inches tall.

#### RECOGNITION

Each chapter participant who completes the 27-4 LRRP requirements shall be authorized to wear the LRRP Guidon and mileage tabs. These patches recognize chapter members/participants for their long-distance riding accomplishments. Each awardee shall be entitled to continue wearing this award regardless of their chapter affiliation should they leave 27-4.

# **OVERVIEW**

The 27-4 LRRP one time participation fee may be made at any time and does not exclude any miles logged before payment. All miles logged will become effective on day one, when an individual begins riding with the chapter and will run continuously throughout duration of their participation with the chapter. Upon completion of eligibility requirements participants will be awarded the LRRP Guidon followed by "total miles" tab patches at designated mileage increments All patches will be awarded at our chapter's annual Christmas party. The 27-4 chapter LRRP is not mandatory, participation is optional to all chapter members.

# QUALIFICATIONS

To be eligible for award of the Chapter LRRP patch you must meet the following criteria:

- 1. Those persons eligible to participate are (Full, Support and Auxiliary members), Riders and Passengers.
  - a. Members Not in Good Standing, (NIGS) will not receive credit for any miles ridden while NIGS.
- 2. The CVMA® is a Riding Association, as such the only mode of transportation allowed for the LRRP is the motorcycle. Hauling your motorcycle to events by truck, trailer or any means other than riding or traveling to an event by any means other than a motorcycle then obtaining a bike at the event location is not permitted and those event miles will not count for LRRP. Additionally, you must be wearing your CVMA® vest in order for mileage to be honored. The only exceptions being that during periods of inclement weather it is acceptable to wear rain gear over or remove the vest replacing it with rain gear. Removal of the vest will be acceptable in No-fly zones and in cases of extreme heat where safety may be of concern.
- 3. Travel to and from any chapter meetings, travel to and from events approved by the Chapter Executive Board are usable miles for credit. Travel to and from State meetings or events, travel to/from out of state approved CVMA® events and rides are qualifying miles. Examples are Blue Ridge Thunder, Memorial Day/Veterans Day Parades, D-Day Anniversary Ride, 27-1 Poker Run, NC CVMA Benefit Runs, CVMA National Meeting, Military Funeral Escort.
  - a. Personal weekly rides or daily travel does not constitute recognition for the LRRP.
  - b. Informal group rides not sanctioned by the CVMA® or approved by the CEB will not count.

- 4. Good Faith Effort: If a breakdown or accident occurs that renders the motorcycle inoperable while traveling to, from or during an event and it becomes necessary to trailer the bike to a maintenance facility or to the rider's residence, miles ridden up to the or breakdown or accident will be honored for LRRP.
  - a. If due to the breakdown or accident an event is missed but repairs are made, and the rider can return to their residence on the motorcycle round trip miles will be honored.
  - b. If after a breakdown or accident the rider can obtain a loaner or rental bike in order to complete the ride those miles will be honored.
- 5. Pay a one-time \$20 participation fee to cover costs of all patches including the initial Guidon patch and all accruing mileage tab patches.
- 6. START/FINISH: Yearly mileage accumulation begins on the day of the Chapter's annual Christmas party and will end on the day prior to the next annual Christmas Party. Upon closure of the yearly mileage log the individual appointed to maintain the log will provide the Chapter Secretary with a copy to be maintained with the chapter's records.
- 7. Mileage is typically obtained from odometer of the motorcycle that was ridden or may be obtained from the ride route planned using MapQuest or Google Maps. Mileage starts and ends at your place of residence.
- 8. Submit an e-mail recording the miles traveled and the event name/location to the LRRP records keeper. A safe return home email addressed to the google group is acceptable. Please include name or road name as messages sent from cell phones do not always identify the sender. Please include in the email the following information:
  - a. Written explanation of the route to be ridden if the mileage is more than the calculated mileage from the mapping tools, (i.e., excess mileage was because of a side trip in route to/from the planned event). Excess mileage or variations in travel is subject to review and approval of the CEB.
  - b. Detailed explanation of the event.
  - c. As an option, for approved events outside of the chapter one can qualify miles via the consolidated attendance roster and route with the mileage determined by the designated chapter Road Captain for members that participated in the group ride to/from each approved event.
  - d. For chapter approved events a CVMA 27-4 sign in roster will be available for chapter participants to obtain credit for attendance at the event and therefore record mileage associated with the event.

NOTE: Participants are encouraged to maintain their own personal ride and mileage log.

9. To mark continual accomplishments in the LRRP a mileage tab will be awarded. Each tab will have the total cumulative miles ridden. It is intended to be placed on top or bottom of the LRRP Guidon patch. The chapter 27-4 LRRP guidon patch represents participation in the chapter's LRRP program. The first accumulative mileage tab will be awarded at 2,500 miles. All tabs will be at 2,500-mile increments; 5,000 miles, 7,500 miles, 10,000 miles, 12,500 miles up to 15,000 miles. Miles accumulated after the 15,000 mile award will then accrue by 5,000-mile increments; 20,000, 25,000, 30,000 and 35,000 and upward. Extra/replacement guidon patches will cost \$10 and mileage tabs will cost \$4.00.
